### General Guidelines for all parents with children attending Monday Fun: *(please read and initial or "x" for online submittal)*

\_\_\_\_\_ I understand that BHEA is Christian based; however, teachers are not required to sign a statement of faith. I understand that it is my responsibility to read each teacher's bio on the BHEA website and to make decisions appropriate for my own family.

\_\_\_\_\_ I have read all BHEA conduct rules, including the dress code policy from the BHEA handbook. I understand that I am responsible for helping my child to behave respectfully and courteously.

\_\_\_\_\_ I realize that I must be financially responsible for any damages caused by deliberate acts of negligence by my child to the building or its equipment.

\_\_\_\_\_ I understand that I must sign up for a service position while my children are in classes. *(teachers are excluded from this policy).*

\_\_\_\_\_ I understand that as a parent, I should help ALL children be courteous and respectful in the building. Please remind any child who may be running, yelling, etc., to act respectfully in the church. Please remind children not to use the aisle way in the sanctuary and not to play on the stairs.

\_\_\_\_\_ I understand that children under age 14 may not be dropped off unless I have an emergency. In case of emergency, I will find a friend to be my child's temporary guardian and will fill out the proper paperwork at the information table.
